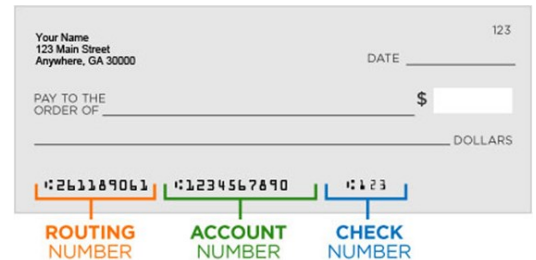

I understand and agree that as this is an electronic transaction, adequate funds must be available for withdrawal from my account by the selected contribution date. In the case of an ACH transaction being rejected for Non-Sufficient Funds (NSF), submission error, or other bank related return reasons I understand and agree that the Church may at its discretion resubmit the ACH debit transaction within thirty (30) days. I acknowledge that the origination of ACH transactions to my account must comply with provisions of U.S. law and agree not to dispute this recurring billing with my bank so long as the transactions correspond to the terms indicated in this authorization form.
